Updating your privacy notice

If we have provided your website, we will have included a generic privacy policy.

GDPR requires you to be more specific in how you are using personal data. You should update your privacy policy detailing how you will use the information.

It should be simple to read, concise and appropriate to the audience of your website.

Your privacy statement should provide a good overview of your data use. When collecting information you may refer and link users to your privacy statement. You can also supplement it with additional statements built into your pages to aid transparency, explaining why you are collecting information and how it will be used.

What to include in your privacy notice

Headings or topics you might want to consider covering:

- Who are we
- The personal information we collect and use
 - What personal information do we collect
 - Why do we collect your personal information
 - Lawful basis for processing
 - How we use your personal information
 - How long your personal data will be kept
 - Who we share your personal information with
 - Keeping your information safe
- What rights do I have
- Who to contact

Further details of what to include in your privacy notice

• Who are we

An introduction to your organisation and what you do

- The personal information we collect and use
 - What personal information do we collect
 - Detail the information you collect e.g. contact information, billing details
 - Why do we collect your personal information
 - Explain why you need the information e.g. to respond to requests, to fulfil orders etc.
 - Lawful basis for processing
 - Use the ICO website to establish the lawful basis for the processing of information that you carry out
 - How we use your personal information
 - Explain how the information is used and stored
 - How long your personal data will be kept
 - You should have a data retention policy as part of your GDPR compliance which determines how long you will keep personal information for. You should provide detail of this.
 - Who we share your personal information with
 - If you transfer or pass on information you need to detail this.
 - o Keeping your information safe
 - Detail steps taken to protect personal information.
- What rights do I have

You should list the rights applicable to those whose data you hold. We included an example of this below:

- The right to be informed we aim to be transparent about the information we collect and why we are using it. You can request further information from us at any time
- o The right of access you can request the information we hold about you
- The right to rectification you can request us to correct any mistakes in the information we hold
- The right to erasure you can request us to delete the information held on you
- The right to restrict processing you can request us not to process your data in a particular way
- The right to data portability to have us transfer your information electronically to yourself or another provider
- o The right to object to object to how we are using your information
- o Rights in relation to automated decision making and profiling.
